This Privacy Policy does not cover third parties or their services and we do not take any responsibility for how such third parties may use any information they collect.




FROM PARENTS:

3. How we use the information

We use the information held about you in the following ways and for the following purposes:


- To register and respond to your application and career or enrollment queries.
- To provide you with the services and functionality offered through the site and to fulfil your requests
- To respond to, or follow up on, your comments and questions, and otherwise provide customer service.
- To occasionally carry out surveys to ensure that we are providing you with what you are interested in.
- To perform statistical analysis.
- To notify you about changes to our services and communicate with you when necessary

4. Will we share your information with anyone else?

- No. We do not share your information's with non- relevant staff members or any third/outside party without your consent.
- We appoint consultants, experts and other advisors to assist CPS in fulfilling its obligations and need to share your information with them if it is relevant to their work.

5. Where we store and process the information

- Digital information we collect from you is partly stored on our on-campus servers and cloud servers.
- Physical documents are kept safely in secure lockers inside the school
- We will retain your information for the period necessary to fulfil the purposes outlined in this Privacy Policy and as otherwise needed to comply with applicable law and internal company policies.





6. Security

- We understand the importance of securing your personal information in our care. We utilize
 reasonable security measures that include technical, administrative and physical safeguards to
 secure your personal information in our care from unauthorized access, modification,
 disclosure or destruction.
- However, if you provide us with personal information over the internet, you should be aware
 that the absolute security of the information transmitted over the internet or stored in
 electronic storage cannot be guaranteed to be 100% secure. While we take reasonable efforts
 to protect such personal information, you acknowledge that we cannot ensure or warrant the
 security of any personal information provided by these means and you provide it to us at your
 own risk.

7. Password and Confidentiality


- If you are provided with a user identification code, password or any other piece of information
 as part of our security procedures, you are responsible for maintaining the confidentiality of
 your password and username for the Site and you are responsible for all activities that are
 carried out under them. We do not have the means to check the identities of people using the
 Site and we will not be liable where your password or user name is used by someone else.
- You agree to contact us immediately and inform us of any unauthorised use of your password
 or user name of which you become aware. We have the right to disable any user identification
 code or password, whether chosen by you or allocated by us, at any time, if in our opinion, you
 have failed to comply with any of the provisions of this Privacy Policy or the Terms and

8. Your data protection rights

- We may request proof of your identity before we disclose such information to you. That's so

10. Violation

Violation of this policy or misusing the user's personal information's shall be treated in accordance with UAE Data Protection Policy Article 21


UAE Data Protection Policy Article 21

Shall be punished by imprisonment of a period of at least six months and a fine not less than one hundred and fifty thousand dirhams and not in excess of five hundred thousand dirhams or either of these two penalties whoever uses a computer network or and electronic information system or any information technology means for the invasion of privacy of another person in other than the cases allowed by the law and by any of the following ways:

- 1- Eavesdropping, interception, recording, transferring, transmitting or disclosure of conversations or communications, or audio or visual materials.
- 2- Photographing others or creating, transferring, disclosing, copying or saving electronic photos.
- 3- Publishing news, electronic photos or photographs, scenes, comments, statements or information even if true and correct.


Shall also be punished by imprisonment for a period of at least one year and a fine not less than two hundred and fifty thousand dirhams and not in excess of five hundred thousand dirhams or either of these two penalties whoever uses an electronic information system or any information technology means for amending or processing a record, photo or scene for the purpose of defamation of or offending another person or for attacking or invading his privacy.
